Agenda for Change (AfC) 2023 deal – non-pay elements We are continuing to work on the implementation of the three sections of the non-pay elements of the 2023 AfC agreement. We have some updates to share as follows:

- Reduced Working Week as previously stated, teams should discuss how this might work for them, but they should not make any changes to their working pattern at present. However, as the reduced working week officially took effect on 1 April, the hours worked by all Agenda for Change staff (including all part time and all full-time staff) must be clearly and carefully recorded in the systems we use. This will ensure you are paid correctly, and we are recording costs accurately. Guidance for users of SSTS, eEES, Optima Rostering, and JobTrain is attached to the email used to send this brief. Users of each of these systems must read this and follow the guidance relevant to the system they use. If you have any questions, there is a point of contact listed in each system specific section.
- Band 5 nursing review some initial information has been shared nationally on the ambitions for ensuring a defined process for a Band 5 nursing review. This is also attached to the email used to send this brief. We would stress the dates suggested are indicative for now and we will share further updates as they become available.
- Protected learning time a local working group is being set up to implement a consistent approach to protected learning time.

The key point we want to underline to everyone reading is this: while you **should not** make changes to your working pattern to reflect the reduced working week, you **should** ensure time worked is being clearly and accurately recorded in systems such as SSTS, as per the attached guidance.
