COVID-19Brief



Here is the brief for Friday 29 October 2021.

ARI staff vaccination clinic Next week (w/c 1 Nov) the ARI staff vaccination clinic (based in Eye Outpatients, Level 3, Yellow Zone) will operate Monday – Friday as usual. **However, this will be the last full week for the clinic.** The final clinics in this location will take place on Wednesday 10 and Friday 12 November. After this, it will not be possible to get your 'flu and/or COVID booster in this location.

If you have yet to book your appointment, <u>please do so using the online portal</u>. Booking is requested whenever possible, to ensure a timely service. At the time of writing, more than 500 appointments are available on the above dates. The clinic is only able to offer a very limited drop-in facility, due to space constraints. If the clinic is busy, staff dropping in for vaccination may be asked to leave and return later.

COVID-19 and international travel There are two important updates on international travel:

The European Commissions has confirmed Scotland and the rest of the UK have been formally
adopted into the European Union's Digital Covid Certificate (EU DCC) scheme. All Covid status
certificates will be recognised across Europe on Monday 1 November as the UK joins the EU
scheme which provides the means for QR codes to be scanned and verified as being officially
issued.


The change will open up ease of access for travellers to more than 40 countries covered by the certification scheme. It covers travel to Europe and those countries which, like the UK, are affiliated with the EU DCC. It will also enable better access to facilities like bars and other venues where this is required in those countries which have chosen to use the EU DCC domestically.

Users of the NHS Covid Status app will have their vaccination status automatically updated when they login. Scots travelling to the EU and countries covered by the scheme who have downloaded a PDF version with QR codes on their mobile device, or anyone who has a printed letter with their COVID status dated before 7 October will need to either download the app or request a new letter.

2. The final seven countries have been removed from the international travel red list, meaning travellers to the UK from those destinations will no longer have to stay in hotel quarantine for 10 days on arrival. The decision was made on a four-nation basis and will take effect at 4am on 1 November. It affects arrivals from Colombia, Dominican Republic, Ecuador, Haiti, Panama, Peru and Venezuela. Despite no countries remaining on the red list from next Monday, the policy is continuing and some managed quarantine capacity will stay in place in Scotland in order to react to any change in risk assessment that would see a country added to the red list.

Switchboard staffing request The NHS Grampian Switchboard provides a centralised call handling service on a 24x7x365 basis to NHS Grampian staff and members of the public. As well as call handling the switchboard also deals with the following critical services:

- Activation of Clinical Emergencies (2222 calls),
- Activation of violent incident calls (747 calls)
- Activation of fire calls (666 calls)
- Lift emergency calls.
- The activation, transfer, and repair/replacement of Bleeps,
- Major Civil Incidents,
- Helicopter Landings,
- Fire, intruder and personal attack alarm monitoring
- Rotawatch (OOH contact handling and unscheduled system administration)

We are presently experiencing significant staffing challenges to cover switchboard shifts safely and would like to request:

- 1. If any staff member would like to notify an interest in being on the bank to be able to help support this critical service (note training will be provided) contact eHealth management as follows: gram.ehealthadmin@nhs.scot
- 2. That staff avoid dialling 0 and asking for the operator to have calls routed internally. Please use the online telephone directory (via the intranet homepage) or use the interactive voice response (IVR) to ask for the person or department required. This will allow depleted switchboard staff to focus on handling critical calls and incoming calls from the public and partner organisations outwith NHS Grampian.
