

Vaccine trial opportunity We are once again supporting COVID-19 vaccination trials, this time working with Moderna to trial their Omicron specific jab. This will start next week, and we are keen to recruit trial participants as quickly as possible. If you have already received 2 or 3 doses of an approved COVID-19 vaccine (your last injection should have been at least 90 days ago) and haven't had COVID-19 in the last 90 days, you may be eligible. All the information you need, along with contact details for the trial, is in the flyer attached to the email used to send out this brief.

Aberdeenshire vaccination appointments We are currently appointing people aged 75 and over for a COVID-19 Spring booster. On Tuesday we became aware some citizens in Aberdeenshire had not been given appointments at their nearest clinic. Since then, the vaccination team have been working hard to understand the scale of the problem.

We estimate approximately 4,000 people have been given appointments at clinics other than their local centre. We have already started phoning people directly to rebook their appointments. If anyone has received an appointment at a clinic that is not closest to where they stay or is not convenient to get to, they do not need to wait for us to get in touch; they can call the national helpline on 0800 030 8013 and rearrange. Letters are being sent today to apologise and explain what they should do next. Individuals are not obliged to reschedule; if the appointment they have been given suits them, they are welcome to keep it.

There is no evidence of similar issues in Moray or Aberdeen City; we are working closely with the national appointing team to understand why this happened and how it can be avoided in future.

Baird & ANCHOR Project Update As previously highlighted, construction is well underway on both these projects. However, COVID-19, Brexit, and changing global regulations have resulted in supply chain issues, material shortages, price increases and labour shortages. An additional £1.9M of funding has been agreed by the board of NHS Grampian to meet these challenges. In addition, the 'bring into operation' dates have been amended, as follows:

- ANCHOR Centre - August 2023
- Baird Family Hospital - March 2024
- Demolition of AMH - August 2024

These dates will continue to be reviewed over the life of the project and will be confirmed six months before handover from our construction partners to allow for the smooth transition to bring into operation for the benefit of staff, patients, and the wider population.

Pensions update Here is today's update for members of the NHS Scotland pension scheme:

Continuation of the temporary suspension of the pension scheme abatement rules for retired NHS staff A regulation was introduced in April 2020 that suspended pension scheme rules that placed limits on the working hours and earnings of retired staff who returned to NHS employment. These arrangements will continue indefinitely but will be reviewed weekly.
