## COVID-19Brief



Here is the brief for Thursday 23 September 2021.

Reminder - Eye protection Only products ordered via <a href="gram.covid19supplies@nhs.scot">gram.covid19supplies@nhs.scot</a> or PECOS meet the required H&S and IPC Standards. This Personal Protective Equipment (PPE) is intended to prevent eye exposure to chemicals, blood or bodily fluids by splash or spray (including transmissible infectious agents, such as COVID-19). It is very important that while wearing wear visors or goggles whilst undertaking any aerosol-generating procedures if the FFP3 device used does not have a valve. If the FFP3 device you use has a valve, only a visor can be worn. Please be aware that if you are using FFP3 equipment, you must wear the same model of eye protection that you wore when being fit tested. If you wish to change your eye protection, you will be required to be fit tested again with the appropriate eye protection.


- Eye protection should be removed after providing direct care for patient(s) isolated with suspected or known infectious pathogens such as COVID-19 and whenever departing from the high & medium risk COVID-19 pathways (Red and Amber)
- Staff must not purchase items independently as these may not meet the required safety standards.
- Regular corrective spectacles are not classified as Personal Protective Equipment and do not protect the eyes from exposure risks, therefore those wearing spectacles should also wear goggles. If the goggles available do not fit over the prescription glasses then a visor should be worn.
- Safety glasses are NOT currently considered eye protection under EN standards and therefore not recommended in Scotland at present.
- Eye protection must be changed if damaged, soiled, compromised, or it becomes uncomfortable. There are two types of visor and one type of goggle available, which have recently been reviewed by IPCT colleagues on behalf of the local PPE Cell. Please be aware that single use, disposable visors remain the primary stock item held in NHSG which are suitable for the application of both droplet and airborne precautions. Reusable goggles are also available, for droplet and airborne precautions, where it has been risk assessed that visors are not suitable to undertake care delivery.

Autumn/Winter vaccinations – ARI clinic If you have booked your vaccination appointment in the ARI clinic, (Ophthalmology out-patient department theatres, Level 3, Yellow Zone), please access this via the staircase directly across from Marks & Spencer in the main concourse. The route is signposted. Please only use the lift if absolutely necessary, as footfall will be greatly increased in an already busy clinical area. The waiting area for this clinic is small, therefore do not arrive more than 5 minutes in advance. Please ensure you check-in at the desk before joining the queue.

If you are having any issues recovering the account details required to book your appointment, you should call the national COVID-19 Status Helpline on **0808 196 8565.** The helpline is open every day from 10am to 6pm.

**Text scams** We continue to receive reports of various scam text messages, received by staff and the general public alike. These have covered everything from links to book PCR tests to access to proof of vaccine certification. What these scams all have in common is a request for payment. Please remember (and tell friends, family, neighbours, colleagues) that there is **no charge** for any of these services on the NHS. Any message requesting for payment for these services is not genuine and should be deleted.

**Temporary Stock of Alcohol Based Hand Sanitisers** At the start of the pandemic we had several alternative Alcohol Based Hand Sanitisers provided across the system, where stock of the usual products was very low. Alcohol Based Hand Rub (ABHR) products are now being supplied steadily through the National Distribution Centre (NDC) and can be sourced through PECOS or via your Ward Product Management (WPM) service. As per Infection Control guidance any products sourced outwith this route should no longer be in use and should be disposed of locally (large quantities can be returned to the Central Stores Warehouse).

**Unpaid Carers and hospital discharge** This week sees the launch of a six-month pilot project to look at how we can better involve and support Unpaid Carers in the discharge process for the person they care for. Staff at three Community Hospitals - Chalmers in Banff, Glen O'Dee in Banchory and Stephen Hospital in Dufftown – will be undertaking a short questionnaire with all unpaid carers to help them be more involved in the discharge process and ensure that they have all the information they need. Anecdotally we know that many carers do not feel as involved as they should be in the process and this pilot will help us to look at how we can embed best practice and fulfil our obligations under the Carers Act (2016) across our organisations.
