Our Winter plan When the Grampian NHS board met on 1 December, they supported two papers, setting out our plan to meet healthcare demand over the winter, and our plan to communicate with people In Moray, Aberdeenshire, and Aberdeen City, to help them stay healthy and safe. You can read both these papers here – items 7 and 8 on the agenda – and we have already started putting the communications plan in action. Adverts are running on Northsound and Moray Firth Radio, and across social media platforms, focusing on Know Who To Turn To. There will be more to come over the next few weeks, including videos from our colleagues in pharmacy and optometry.

Hospital Supplied Scrubs/Theatre Greens no longer to be used by non-theatre staff Given there is no ongoing IPC (Infection, Prevention and Control) requirement for the use of scrubs outside of theatres - other than in areas where this was agreed before the COVID pandemic - scrubs are no longer to be used by non-theatre staff, effective immediately. This decision will relieve unnecessary pressure on linen services, at a time when automated ironing and folding of all scrubs is not currently possible due to equipment failure and the volume of scrubs being processed. Updates to Workforce Systems – thank you for your patience The HR Service Centre has recently undertaken two significant pieces of work – transferring 7,200 bank workers records to weekly pay frequency and the regrading of 700 Band 2 HCSWs to Band 3. Amendments to employee's records should have been made in eESS, for interface to ePayroll to start payment. However due to volumes, a very tight processing window of opportunity, and the need for eESS to be updated nationally to recognise a HCSW Band 3 in its post hierarchy, a decision was taken to bypass eESS and make the changes direct in the payroll system. This redirecting of system assured that the necessary pay changes were made on time. eESS Managers who are responsible for bank workers and/or Band 2 HCSW's who have been recently regarded to Band 3 are righty querying why eESS records are not updated. The changes will be done in eESS, with a predicted completed date by early January. Please be assured staff and bank workers are being paid correctly. Your patience and understanding whilst the eESS process this significant volume of work, in addition to their normal workload, would be appreciated.

Uniform Collection If you are waiting for new uniform, please check your NHS email to see if yours is ready; the sewing room have issued more than 450 collection requests over the last week. Please check your email promptly, or encourage your teams to check their inboxes, if you manage staff awaiting uniform.

The Sewing Room will be closed on the Public Holidays, so please make every effort to collect uniform this week. You do not have to come and collect your uniform personally - a colleague can collect on your behalf. The sewing room is open for collections Monday to Thursday 8am-2.45pm and 8am-12pm on Fridays.
