**Industrial Action update** As you will be aware, several unions representing NHS staff have been balloting their members on possible industrial action. Some of these ballots have closed, others are ongoing. We await further updates from the relevant unions on the outcome of these ballots and their planned next steps. In the meantime, a Short Life Working Group is meeting weekly to discuss the possible impact of any action on our services, and any necessary contingency arrangements. Please be assured that we will share as much information with you as we can, once we have certainty on what form industrial action may take.

Changes to Financial Controls Around Invoice Processing Previously we've highlighted the need to be vigilant to the increased risk of fraud, and particularly procurement related fraud, in these challenging times. Criminals are actively targeting large public sector organisations such as NHS Grampian and looking to exploit any perceived weaknesses in our processes. An important aspect of how we protect ourselves against this risk are the controls we have in place to manage the purchase of goods or services. We have strict procurement processes outlined in our Standing Financial Instructions to ensure all orders for goods and services are made through authorised suppliers, subject to proper due diligence checks, and all commitments are within delegated financial limits. All staff responsible for procurement activity are reminded NHS Grampian's policy is only to pay for goods or services where the order is supported by a valid contractual agreement and/or a valid purchase order.

During November, it is our intention to write to all suppliers reminding them of our policy and that NHS Grampian will not pay invoices for goods or services unless supported by a valid and properly authorised purchase order or contractual agreement.
