**Finalisation of Bank Duties** We are dealing with increasing complaints, from bank workers, relating to chasing payment for shifts which departments have not finalised. Everyone has a right to be paid accurately and on time for the work they do, and the bank office makes a significant effort each week to remind every department of their responsibilities around this. Unfortunately, despite this, there are still shifts assigned to workers on Healthroster which have not been finalised and which the NMAHP Bank Office have not been instructed to remove.

Please be aware notes left on Healthroster are not monitored or actioned. If changes are needed, the bank office **must** be informed directly. Please use the 'Send Notification' function on Healthroster to quickly notify the team of any cancellations or DNAs, or email <a href="mailto:gram.nmahpbank@nhs.scot">gram.nmahpbank@nhs.scot</a> if you prefer. Adjustments to start, end, or break times are done by you before finalising and do not need to be communicated to the bank team. As per the NMAHP Bank Procedure, shifts **must** be finalised by the deadline set by the Central Rostering Team. Any service which repeatedly does not finalise shifts on time for salary payments may be restricted from using the bank service. Please help the bank team, and ensure all colleagues are paid appropriately and on-time.

Gloves – to use, or not to use? On World Environment Day, with the theme 'Solutions to Plastic Pollution' we're launching a drive to reduce unnecessary glove use across health & social care. We are committed to reducing plastics pollution; one of the ways to achieve this is to only use non-sterile disposable gloves when they are needed. The Infection Prevention and Control, Waste Management, Sustainability, and Occupational Health teams would like to understand why non-sterile disposable gloves are used, so later this week an anonymous survey will be launched to understand why, when, and where, these gloves are used.
